Your privacy is important to us, and we value your trust. This Online Privacy Notice (this "Notice") describes the online privacy practices of TD Securities (USA) LLC ("TD Securities", "we", "us", and "our") applicable to individuals who visit, use or interact with our TD Securities website located [here](#).

This Notice explains the following:

How we, directly or through service providers, may collect, use, disclose and protect your personal and non-personal information (herein "information") when you visit, use or interact with us through our website.

Consent: By visiting, using or interacting with us through our website, you agree to this Notice.

Check the Effective Date: This Notice may be revised from time to time, so we encourage you to periodically check the current version available. If we revise this Notice in a material way, we will change the "Effective" date shown at the top of this page and provide a conspicuous notice on our website before any changes take effect.

Important – This Notice is useful to you in describing our activities with respect to your information when you visit our website, and the options and choices described below are available to you as well.

Types of Information We Collect

When you visit or use our website, we may collect information from your computer(s) and your smartphone(s), tablet(s) or other mobile device(s) (together referred to as "mobile devices"), as well as information you directly provide to us through various features of the website. This information includes:

- The make and model of the computer(s) or mobile device(s) you use to visit, use, view or interact with our website, as well as browser version, hardware and operating system;
- Search terms you used on our website;
- Which of our online content you view, access or click on; and



- Your Internet Protocol (IP) address and related information, such as your general geolocation (city, state, and country) and MAC address;
- Your browsing habits on our website or websites offered by third parties, such as the search terms you entered on these websites, what pages you visit, how long you stay and what actions you take;
- Your personal information which you provide to us through the website, including your first and last name, phone number, and email address.
- Any actions you take in response to electronic communications that we send to you, such as opening the message or clicking an embedded link.

Our service providers or third parties may also collect information about your browsing habits on websites offered by third parties and use it for the purposes described below.

Third-party information

We may also collect information about you from additional online and offline sources, and other third-party sources as permitted by law.

Association of information – General Geolocation Data

We may associate the above information from your computer(s) or mobile device(s) through various means, including a unique identifier (such as IP address or unique device identifier) by using cookies (small data files saved to your browser by websites). When used, these unique identifiers enable us to identify your general geolocation (city, state, and country). We use your general geolocation to direct you to the appropriate TD Securities website for your jurisdiction or region, and to support the rendering of information within your device and browser services.

How do we use your information?

We may use the information discussed above in the following ways:

Deliver digital content to you, which includes:

- Recognizing you when you return to our website;
- Facilitating the operation of our website.

To address your requests:

- For California Residents (only): Verification of your identity in order to respond to a privacy rights request you have made with respect to your personal information, including: provision of a copy of all of your personal information that we have on file, correction of inaccuracies, and deletion.

Conduct reporting and development, including to better understand our website visitors and to improve our website.

In other ways as required or permitted by law or with your consent.

Aggregated/anonymized information

We may also aggregate or anonymize information about you (so that it does not identify you individually). This aggregate or anonymized information is not subject to this Notice, and we may use it as permitted by law.

Disclosure of your information

We may disclose information about you, and information collected from your computer(s) and mobile device(s) for everyday business purposes, including with:



- Other individuals or entities, when we believe that disclosure is necessary to detect, prevent or report suspicious activities, prevent physical harm, financial loss or violations of our agreements and policies; and
 - Regulators and other organizations or individuals who are legally entitled to receive such information.
